# CHICAGO VFC STAFF POSTPONING IN-PERSON VISITS

Until further notice, the Chicago staff will not be conducting in-person VFC visits or IQIP (formerly "AFIX") visits to your practice.

### Please also alert Chicago VFC if:

- Your hours of operation change in any way in response to the COVID-19 response, including if your clinic is closing down operation (see below)
- You need immediate help with storage and handling questions.

# **VFC Provider Office Closures**

If your office decides to close for more than a few days, we suggest the following actions to best ensure the safety of your vaccines.

- 1. Download your Digital Data Loggers (DDL's) before you leave. After being downloaded, your DDL's storage capacity is greater than two months. Downloading them ahead of time will allow you to monitor any temperature excursions when you return from the closure. If there is an excursion when your clinic returns to work, email the DDL files from that excursion to <a href="mailto:chicago.org">chicagovfc@cityofchicago.org</a>. If there is no excursion, then you are good to vaccinate upon returning.
- 2. Have staff check in with engineers or building managers and remind them that vaccines are being stored in the clinic and that power must not be cut off at any time. Also put a sign on the outside of your office that states the same.
- 3. Please consult VFC before making the decision to transfer or relocate vaccine to other clinics. In almost all situations where your units are functioning properly, we will elect to leave your vaccine at your clinic for short office closures.

1)In I-CARE, complete the Enrollment Form.

2)Print the Provider Agreement and have the Medical Director review and sign it. Then return it to the Chicago VFC Program via email (chicagovfc@cityofchicago.org) or fax (312-746-6220).

The Provider Agreement is the only document that must be <u>printed</u> and <u>submitted by email (chicagovfc@cityofchicago.org) or fax to 312/746-</u>6220. All additional information is captured directly in I-CARE.
