#### **Updates to Pfizer's COVID-19 Vaccine**

- **Age Eligibility Change**: Pediatric patients aged 12-18 can receive Pfizer's COVID-19 vaccine
  - Vaccine Spacing: Patients no longer need to wait 2 weeks before/ after receiving Pfizer's COVID-19 vaccine to receive other vaccines Storage Updates: Pfizer's COVID-19 vaccine can now be stored in your standard freezer for 2 weeks and then in the refrigerator for 30 days. Managed properly, that's 6 weeks of vaccine viability. This vaccine also now comes in packaging of either 450 or 1170 doses. Packing for smaller orders can be requested in doses of 50 or greater for delivery as well.

With the vaccine spacing and age eligibility updates, your practice can administer this vaccine **alongside** any other adolescent immunizations patients may be due for (i.e. HPV, meningococcal, Tdap, flu). Please see the attached 5/14 HAN release for details.

- Make COVID-19 appointments for your 12-18 pediatric population
